## **GENERAL PROGRAM INFORMATION**

The Grayson College Associate Degree Nursing LVN-RN program accepts approximately 20\* students each fall and spring semester. The Grayson College Nursing Department reserves the right to make changes in program enrollment capacity. \*Subject to change at the discretion of the Grayson College Nursing Department.

The Grayson College Associate Degree Nursing LVN-RN program is a 1 ½ -year program. Nursing courses (RNSG) are separated into three semesters, 16 weeks each, during Fall and Spring semesters only. Students will not take nursing courses or attend clinical during the summer, unless otherwise indicated by the Grayson College Nursing Department. Students can choose to take other academic courses towards a future Bachelor Degree of Nursing (BSN) during the summer semesters.

Accepted students should plan to be in class or clinical approximately four days a week at the start the nursing program courses. There are approximately 5 hours of lecture content and 1-3 hours of lab class per day and 12-15 hours of clinical per week. These vary from semester to semester, but students will most likely be in class or clinical four days a week throughout the four semesters.

Services are available to assist students with various needs based on race, creed, gender, national origin, or disability. Professionally trained counselors are available to all students and are prepared to assist students in achieving success. A wide variety of counseling and support services are available. For example, a Foreign and ESOL Student Advisor is available to assist international students with a wide variety of needs.

### Class/Clinical

If a student has a medical condition which may compromise their ability to care for patients, a medical release from their physician may be required. Based on the environment, students may be exposed to possible infectious diseases.

Students must comply with class and clinical attendance requirements according to the nursing student handbook guidelines which are published annually. Students who are absent from clinical for physical or mental illness, surgery, or pregnancy reasons must present a written release from a physician before being allowed to return to the clinical setting. Students who are anticipating surgery or delivery of a baby during an academic semester are advised to wait until the following semester to apply to the nursing program.

Clinical sites include locations in: Sherman, TX / Denison, TX / Durant, Oklahoma

Students must be able to attend each clinical site on a rotation basis every semester. Reliable transportation is required.

## **Supplies and Technology Requirements**

Students admitted into the program will be required to purchase a lab kit that will be used throughout the program. Other supplies may be needed on a semester by semester basis and students will be notified by the nursing coordinator of those supplies during information sessions and mandatory orientation.

Students should have access to internet off-campus in order to complete online coursework and requirements. A laptop or tablet with a camera or webcam and speakerphone will also be required.

Students enrolled in the LVN-RN Program are required to access a learning management system (LMS) used for online, blended, and face-to-face classes at Grayson College. A computer with an internet connection is needed. Computers for student use are available in the Health Science Computer Lab, the Grayson College Library, and other campus computer laboratories. Students will be oriented to the use of LMS and other Health Science technologies at the beginning of each nursing course.

## **NON-ACADEMIC ELIGIBILITY CRITERIA**

Clinical participation is an integral component to completion of required objectives of the nursing program. In order to participate in this clinical component, students must be able to meet the following requirements.

## **Physical / Mental Capabilities**

- A. Visual acuity with/without corrective lenses to identify cyanosis, absence of respiratory movement in patients, and to read small print on medication containers, physicians' orders, monitors, and equipment calibrations.
- B. Hearing ability with/without auditory aids to understand the normal speaking voice without viewing the speaker's face and to hear monitor alarms, emergency signals, call bells from patients, and stethoscope sounds originating from a patient's blood vessels, heart, lung, and abdomen.
- C. Physical ability to stand for prolonged periods of time, perform cardiopulmonary resuscitation, lift at the amount required by the clinical agencies, and move from room to room or maneuver in limited spaces.
- D. Ability to communicate effectively in verbal and written form. Ability to speak clearly and succinctly when explaining treatment procedures, describing patient conditions, and implementing health teaching. Ability to write legibly and correctly in patient's chart for legal documentation.
- E. Manual dexterity to use sterile techniques, insert catheters, and prepare and administer medications by various routes such as Intravenous, orally, and Intramuscular.
- **F.** Ability to function safely under stressful conditions, adapting to ever-changing clinical situations involving patient care.

## **Clinical Participation Eligibility (Criminal Background Check policy)**

Based on clinical agency requirements, and in accordance with the Grayson College Health Science Criminal Background Check Policy, any student with the following criminal history will be required to obtain a Declaratory Order from the Board of Nursing prior to admission to the program.

- A. Felony convictions
- B. Misdemeanor convictions, misdemeanor deferred adjudications, or felony deferred adjudications involving crimes against persons (physical or sexual abuse)
- C. Misdemeanor convictions related to moral turpitude (prostitution, public 4 07/2019 lewdness/exposure, theft under \$1,500, computer crimes of fraud, etc.)
- D. Felony deferred adjudications for the sale, possession, distribution, or transfer of narcotics or controlled substances
- E. Registered sex offenders
- F. OIG, GSA and Medicaid Sanctions
- G. Terrorist Suspect List
- H. Pending charges and warrants for arrest

## The following convictions at any time in the past will constitute an <u>absolute bar to</u> <u>participation in clinical rotations</u>:

Criminal homicide; kidnapping and unlawful restraint; indecency with a child; sexual assault; aggravated assault; injury to a child; aiding suicide; agreement to abduct from custody; sale or purchase of a child; arson; robbery; aggravated robbery; conviction under the laws of another state, federal law, or the uniform Code of Military Justice for an offense containing elements that are substantially similar to the elements of an offense listed previously; felony conviction for theft which occurred within the previous five years and any other offense that a facility may impose.

## TEXAS BOARD OF NURSING CLEARANCE DOCUMENTATION

**NCLEX Clearance Documentation:** Provide proof of eligibility to take the NCLEXRN Examination with one of the following documents from the Texas Board of Nursing:

- 1) Blue Card stating eligibility to sit for the NCLEX-RN Examination
- 2) Operations Outcome letter
- 3) Enforcement Outcome letter
- 4) Eligibility Order
- The initial criminal background check will be initiated at the time the application has been processed.
- The Texas Board of Nursing will contact the applicant by email if the applicant is chosen to undergo a
  fingerprinting process. The applicant is responsible for fees associate with the fingerprinting process. The
  Texas Board of Nursing will provide mailed NCLEX clearance documents directly to the applicant several
  weeks after processing the applicant's criminal background information.
- The last day to provide a copy of the proof of eligibility (clearance documents) is by the orientation date. If unable to provide by that date, please notify the program director of the specific circumstances prior to that date.
- The Grayson College Nursing Department is not responsible for any delays regarding the background check process.
- Applicants who fail to provide proof of eligibility will not be admitted into the program. If restrictions are
  placed on the applicant due to the criminal background check, admission into the program may be denied
  or revoked at the discretion of the department.

\*\*Any student with a criminal history listed above will be required to obtain a Declaratory Order from the Board of Nursing prior to admission to the program. The student must inform the Program Director of the outcome of the petition for Declaratory Order by providing a copy of the clearance letter received from the Board of Nursing and the Declaratory Order with or without conditions received from the Board, or the letter of denial received from the Board. Failure to provide documentation prior to admission to the program can disqualify an applicant\*\*

## **ACADEMIC ELIGIBILITY CRITERIA**

## **COURSES**

### **Pre-Requisites:**

Courses must be completed with a 'C' or higher and the most recent earned grade will be counted.

Required to be completed by the application deadline date.

#### **Co-Requisites:**

Courses must be completed with a 'C' or higher, most recent grade will be counted.

Required to be completed by the end of the program in order to graduate.

Courses not completed by the application deadline will not count towards point calculation.

## **Nursing Courses (RNSG):**

Must be taken in sequence and must be completed with a 'C' or higher.

Failed courses will be reviewed at the discretion of the Nursing Department to determine readmission.

#### **MULTIPLE ATTEMPTS AT SCIENCES**

Points are deducted per each attempt at a science course, withdrawals and failing grades count as attempts.

The most recent earned grade will be reviewed, final grades must be a 'C' or higher to be acceptable.

There is **no** expiration for science courses or attempts, see HESI information for science courses over 10 years old.

## **CUMULATIVE GPA**

A minimum 2.5 cumulative GPA is required by the application deadline in order to be eligible for that admissions period.

A cumulative GPA is calculated by including the cumulative GPA from each higher educational institution attended, whether or not the coursework is relevant to the program application.

GPA calculations are not offered via email or over the phone, and a final/official GPA calculation will be determined by the Nursing Department *only*.

#### **TRANSCRIPTS**

- a) Prior to applying to a health occupations program, potential applicants must have submitted official transcripts from each higher educational institution attended to the Registrar/Admissions Office after applying to be a Grayson College student and be fully admitted to Grayson College for the health science application to be considered.
- b) Unofficial transcripts from **ALL** colleges and universities the applicant has attended are required for the nursing program application **whether or not the coursework is relevant to the nursing program degree**. This includes LVN program transcripts stating proof of completion or work in progress.
- c) The transcripts must be updated with the print date current within two years of the applicant's anticipated admission to the nursing program.
- d) Pictures or screenshots of transcripts are not accepted.
- e) If fully admitted into Grayson College, students can print off official transcripts from their MyViking Document Tracking tab. Grayson College transcripts can be printed off from your My Transcripts tab.

#### TRANSFER PROCESS

If you are requesting to transfer from a different nursing program, you must include with your application: transcripts stating final grades/GPA for current nursing courses, syllabi for each nursing course from time the course was completed, and a letter of Good Standing from your current nursing program Director or Dean. Course evaluation can take several weeks. Students who have been unsuccessful in other nursing programs are not eligible for transfer.

## **HESI ADMISSIONS ASSESSMENT TEST**

- a) Students can test at any testing center that offers the HESI admissions test (all required sections must be submitted)
- b) Required Sections: 1) Reading Comprehension, 2) Grammar, 3) Vocabulary & Knowledge, 4) Anatomy & Physiology, and 5)Math
- c) Eligible HESI Test scores must be completed and submitted by the application deadline (current within 10 yrs)
- d) Grayson College requires that students take no more than two HESI admissions tests during a 12-month period
- e) Second and optional attempt at the HESI Admissions test must be submitted no later than the application deadline
- f) \*Applicants must score an overall 74.5% on the HESI Test. If any science courses are over 10 years old, applicant must also score a 75% or higher on the Anatomy and Physiology section of the HESI Test\*

Applicants are responsible for ensuring updated documents are received by our office by the application deadline.

The Nursing Department retains the right to deny applications or documents it deems incomplete, ineligible, or illegible at the department's discretion. *The applicant is responsible for ensuring their application is complete, eligible, submitted, and received by our office by the posted deadlines.* It is recommended that applicants check their emails frequently throughout this process.

## SELECTION AND ACCEPTANCE PROCEDURE

- a) All applications are reviewed by the ADN Admissions Committee after the application deadline.
- b) The number of students admitted to the program varies dependent on clinical space, classroom availability and RN faculty availability. Admission selection is based on a points system and the scholastic readiness of the applicant which is derived from all documents submitted. See page 8 for a detailed breakdown of the points system.
- c) A decision email well be sent to each applicant via email whether it be for acceptance, waitlist or non-accepted. An acceptance list and waitlist will be used until courses begin. Applicants on the waitlist will be notified by phone and email if offered a seat in the class. Number of applicants on the waitlist and their position on the waitlist will not be disclosed. Please do not contact the Nursing Department to inquire about any admissions decision, this information will be detailed in the email.
- d) Accepted applicants are required to provide additional health documents by the mandatory orientation date. These are listed on page 10.

## **REQUIRED IMMUNIZATIONS**

All applicants accepted into the nursing program will be required to have the listed immunizations. Copies of immunization records do not need to be submitted during the application process. However, it is HIGHLY recommended that applicants begin the process of obtaining these records and getting any missing vaccinations. Please note that some of these immunizations take up to six months to complete. Immunizations must be started in time to complete the series before the start of the program. During orientation, the accepted applicants will receive instruction of how to subscribe and upload documents into an immunization tracking program.

If applying for a Fall admissions period, the seasonal flu vaccine needed will not be available until after August, and therefore, is not required to submit until acceptance to the program.

## OTHER REQUIRED HEALTH & ELIGIBILITY DOCUMENTS

For acceptance or waitlisted students only:

Orientation: Attend a mandatory orientation. Failure to attend the required orientation following acceptance will result in loss of admission to the program. The following are required before starting the program or otherwise indicated by the nursing department:

- Board of Nursing Clearance Documentation (see pages 6, 14, and 15)
- 2. BLS CPR American Heart Association or American Red Cross (see page 16)
- 3. Negative TB Testing (see page 16)
- 4. Physical Exam (see page 16)
- 5. Complete any outstanding immunization requirements

Immunization and Health Documents: Applicants must maintain paper copies of immunization records and health documents because a document and immunization tracking company will be used if accepted. The applicant is

responsible for payment of the subscription (more information will be provided during orientation). **Drug Test**: Students must pass a urine drug screen and an additional criminal background check at the beginning of the first clinical course.

The Texas Board of Nursing requires applicants to apply and pay for the Department of Public Safety/Federal Bureau Of Investigation background check and fingerprint scan PRIOR to final admission to any nursing program in the state of Texas. This must be provided by the scheduled orientation date. If unable to provide by that date, the applicant will forfeit their acceptance for that admission period

\*\*\*IF YOU ANSWER "YES" TO ANY OF THE QUESTIONS BELOW OR THE DPS/FBI BACKGROUND CHECK AND FINGERPRINT SCAN DETERMINE THE NEED, YOU WILL BE REQUIRED BY THE BOARD OF NURSING TO BEGIN THE DECLARATORY ORDER PROCESS.

Results of the DPS/FBI Background check and fingerprint scan may prohibit final admission to the program until the Declaratory Order is received by the student from the Texas Board of Nursing. The student must inform the Program Director of the outcome of the petition for Declaratory Order by providing a copy of the clearance letter received from the Board and the Declaratory Order with or without conditions received from the Board, or the letter of denial received by the Board.

If you can answer yes to any of the following you must file a Petition for a Declaratory Order to determine eligibility to sit for the NCLEX®-RN exam following graduation.

For any criminal offense, including those pending appeal, have you;

- H. been granted pre-trial diversion?
- I. been cited or charged with any violation of the law?

## **NOTE: Expunged and Sealed Offenses:**

While expunged or sealed offenses, arrests, tickets, or citations need not be disclosed, it is your responsibility to ensure the offense, arrest, ticket or citation has, in fact, been expunged or sealed. Non-disclosure of relevant offenses raises questions related to truthfulness and character.

## **VACCINES**

 Applicants must be able to complete all required immunizations and health documents by orientation, if accepted to the program.

## **HEALTH DOCUMENTS**

- **CPR:** Obtain American Heart Association (AHA) or American Red Cross BLS Healthcare Provider level CPR certification. All CPR classes must include a skills performance check-off in the course (current within 2 yrs). Our Center for Workforce Learning department offers CPR courses throughout the year, please email them at <a href="mailto:cwl@grayson.edu">cwl@grayson.edu</a> for their availability.
- **TB exam:** Obtain proof of a negative TB (tuberculosis) test. Bloodwork or skin test must be current within 1 yr, or negative chest x-ray that is current within 5 yrs.
- Physical Exam: Required form provided with acceptance/waitlisted email (current within 1 yr).

## **COURSEWORK EVALUATION**

It is the applicant's responsibility to ensure applicable courses are eligible to transfer and meet equivalency before they submit a nursing application. To ensure the transferability of previous coursework completed at colleges and universities other than Grayson College, potential applicants to nursing programs are encouraged to have their coursework evaluated by the Health Science Department at least one semester prior to a program application filing deadline if possible. This procedure is especially important for students with coursework from colleges and universities outside the state of Texas. Applicants must be fully admitted GC students for final/official transcript evaluations.
