

## **College Success Council Meeting Minutes for January 30, 2019**

**Approval of Minutes from January 16, 2018 Meeting:** The minutes of January 16, 2019 were approved - a motion for approval was given by Dr. Williams, and a second by Dr. Washburn.

**Grayson Application Status:** No update given

### **Scholastic Standards:**

- **Policy Update-** Brandi did not have an update.
- **Standardized Academic Plan:** Amanda gave an update on the following: Appeals reviewed to date for Fall 2018, and Spring 2019, Appeals which were denied and Student Enrolled, and Academic Scholarship Assistance/Completion Scholarship Assistance
  - Fall 2018 – Total 207, Approved-135, Denied – 72
  - Spring 2019 – Total 92, Approved – 70, Denied – 22Appeals which were denied and Student Enrolled
  - Fall 2018 – 19
  - Spring 2019 – 14Scholarships Offered
  - Fall 2018 – 8 Students were offered the ASA, received – 6
  - Fall 2018 – 1 Student was offered the CSA, received - 1
  - Spring 2019 – 4 Students were offered the ASA, received – 2
  - Spring 2019 – 0 Students were offered the CSA

It was also discussed if the faculty needed to see the Academic Plan for students on probation. Dr. Washburn said that they do not need to see the actual plan, but do need to see the Academic Standing

- **Technical Updates:** Casey asked about whether we want the student's Academic Standing visible in the Student Planner? This is a feature that is not live yet. Brad Bankhead mentioned that a student should have the right to see their Academic Standing. Others agreed, so a decision of yes was met.

It was also discussed, that the Notes in CAMS are not consistent and work will need to begin to make them standardized in CAMS. Dr. Smarr offered to connect Who's Next with Zogetech for an analysis of Who's Next Notes.

- **Data Analysis:** Dr. Smarr mentioned, that there is no data available for FA after the conversion, but will look at the student level moving forward.

**Student Planner Display Information:** There was a discussion on the student's GPA that displays in the planner. Brandi and Barbara mentioned that it was not an accurate cumulative GPA. Casey mentioned that degree audits need to be reevaluated for the planner GPA to update. There was discussion regarding the difference between the planner GPA, which pulls from degree audit and the cumulative GPA listed on the transcript. It was decided the cumulative GPA is the one that the student needed most and it was determined to remove the GPA completely from the planner since posting the cumulative GPA would cause the system to bog down. Debbie mentioned the possibility of using Zogotech to calculate GPA and store in CAMS.

**ATD Leader College Update:** Dr. Organ gave an update on the ATD Leader College.

**Other:**

- Brandi shared a copy of the Proposed Policy for Credit for Foreign Course. The current policy limits students on what they can use. Brandi asked everyone to please look at the proposal, and we will put on the next meeting agenda.
