<u>Texas Pathways Institute – Session Proposal Discussion:</u> Dr. Washburn shared that she has a webinar next week and the call for proposals is due by Friday, March 1<sup>st</sup>. The registration has not opened up yet, and we could still take a team of 14.

Dr. Machen would like to propose that we send the Program Chairs/Lead Faculty from his area, Dr. Williams area, and Joanna Barnes's area. They could utilize data for improvements in outcomes.

<u>Grayson Application Status:</u> Brandi Furr was not available, but Dr. Harris gave an overview of the Grayson Application Meeting for Branding and Marketing that she attended yesterday.

- Dr. Washburn shared that we have offered to help Temple College on their upcoming QEP. The QEP is on accelerated courses. Dr. Washburn will send out the questions to everyone and asked the team to answer. The information is due back to them by next Friday.
- Upcoming Summit FAQ There are 5 schools (Howard, Midland, Weatherford, Vernon, and Temple) that would like to come on-campus to discuss the 8-week model.
- Dr. Williams was seeking clarity on what courses would be offered free for the dual credit summer bridge first-course free model. Dr. Smarr clarified that in past discussion and the presentation of the data, she had suggested we look at the courses which could garner additional success points, but those were merely suggestions.

  - > Courses leading to AAS
  - Consider Math 1314
  - ➤ An option: buy one get one free

Objective: Get more students to come to Grayson College and stay in college Any class could be free.

• Dr. Machen mentioned that last week we had a representative on campus for the Co-Req grant we were awarded. He stated there are some issues with the data being reported in the CBM002 and 00S reports (developmental) to the state. His initial grant data report was rejected because of these errors. We need a sense of what we are listing. Dr. Machen needs to know the timeline, so he can respond back by Friday of next week. He needs the data back, so it can be resubmitted.

Brandi mentioned that Burr with Unit 4 is very responsive in helping with state reports. Dr. McMillen shared that each success point is \$310 this next year in funding.

Next Step: Dr. Smarr will have Anderson look at each course and how we are coding/reporting. Dr. Smarr will let Brandi know the gaps.
