<u>Texas Pathways Institute – Session Proposal Discussion:</u> Dr. Washburn shared that Texas Pathways would be held in San Antonio on April 24th – 26th. The theme is "Ensure Students are Learning." - > <u>Transfer Hours:</u> There was a discussion on the limit on hours transferred to ensure SACSCOC compliance. *Dr. Machen recommended that the discussion is brought to G8 for consideration.*
