Requirements

- Currently employed as a fulltime paid firefighter in the state of Texas OR an active member of a Texas volunteer fire department (and has been volunteering for at least a year) holding an accredited advanced certification, or a Texas Phase V (Firefighter certification.
- Must be meeting Financial Aid Satisfactory Academic Progress (SAP) at Grayson College.
- Must be enrolled in courses offered as part of a Fire Science curriculum or Paramedic/EMT program.
- Must be degree/certificate seeking at Grayson College (GC).
- Must be registered with Selective Service or Exempt.

Costs Covered

- Tuition only for Fire Science curriculum or Paramedic/EMT program (exemption will not cover additionalfees, books or supplies).
- Lab fees only for Fire Science curriculum or Paramedic/EMT program.

Required Documents

Full-Time Firefighters

- Letter from Fire Chief on department letterhead with current year date, stating current employment status, printed first and last name of fire chief, and official signature from chief.
- Current semester GC billing ledger.
- Payment arrangements for balance not covered by exemption with GC business office. Please review the amount you need to pay after the exemption has been applied.

Volunteer Firefighters

- Letter from Fire Chief on department letterhead with current year date, stating date became a volunteer and service term, with current volunteer status, printed first and last name of fire chief, and official signature from chief.
- Proof of Certification (Advanced Level or Texas Phase V).
- Current semester GC billing ledger.
- Proof of payment authorization from department, if applicable.
- Payment arrangements for balance not covered by exemption with GC business office.
