Required Steps

You are required to complete the following before loan disbursement:

- 1. I understand I must complete the Master Promissory Note and Entrance Counseling at <u>https://</u> studentaid.gov
- 2. I understand I must **accept loans** on MyViking under My Financial Aid
- 3. I understand I must be **enrolled in at least 6 credit hours** for any and all loan disbursements
- 4. I understand **all documentation must be complete** in MyViking under Document Tracking
- 5. I understand I must complete Exit Counseling if I drop below 6 credut hours, withdraw, or graduate at <u>https://studentaid.</u> gov

Award Changes

Grayson College reserves the right to review, reduce or cancel awards at any time due to changes in aid availability; and/or changes in the student's eligibility. Students receiving financial aid are responsible for notifying our office of any additional aid received, such as an additional scholarship, and/or additional funding.

Note: First time borrowers have a **mandatory** 30 day waiting period after the first day of class for disbursement.

Loan Limits

Direct Subsidized Loans

Subsidized loans have a lifetime limit of \$23,000

The minimum amount of loan that can be disbursed per semester is \$500.

Direct Unsubsidized Loans

Unubsidized loans have a lifetime limit of **\$34,500 for dependent students** and **\$57,000 for independent students**

The minimum amount of loan that can be disbursed per semester is \$500.
