### Requirements

- Must file a 25-26 FAFSA online or a 25-26 TASFA.
- Must be considered a Texas resident.
- Must sign Affidavit (Attached).
- Submit copy of original birth certificate.
- Must be a Texas High School graduate and attended at least 3 years.
- Must be meeting Financial Aid Satisfactory Academic Progress (a cumulative GPA of 2.0 or higher, pass 67% of attempted credits, and not exceeding 150% of the desired program length).
- Must complete Eligibility Statement Form.
