



# Aggregate Verification (V5) Independent Student Instructions

## About

This form is required to verify information filled out on the 2026-2027 FAFSA that does not match records verified by the Department of Education.

## Identity Verification

Present one of the following valid, unexpired forms of identification:

- State issued Driver License
- State Issued Identification
- U. S. Passport

## Family Size Information

The form will require you to list all people included in your household. As an example, these may include:

- Yourself and your spouse (if married/not separated)
- Your children if you provide more than half of their support from July 1, 2026 through June 30, 2027
- Other children, if you will provide more than half of their support from July 1, 2026 through June 30, 2027.
- Other people if they now live with you and you provide more than half of their support and will continue to provide more than half of their support through June 30, 2027.
- **Do not** include foster children,
- **Do not** include unborn children (even if they will be born between July 1, 2026 and June 30, 2027)
- Include the name of the college for any household member who will be enrolled, at least half time in a degree program, or certificate program at a post secondary educational institution any time between July 1, 2026 and June 30, 2027

## Income Verification

If your 2024 federal tax information (FTI) was not transferred via the Direct Data Exchange (DDX) to the FAFSA, you will need to provide verification of income.

### Filers:

- A signed and dated copy of your 2024 Federal Tax Return.
- Or, a copy of your and your spouse's (if married/not separated) 2024 IRS Tax Return Transcript. You can request a copy of your and your spouse's 2024 Tax Return Transcript online at [www.irs.gov](http://www.irs.gov) or by calling 1-800-908-9946. Make sure to request the "IRS Tax Return Transcript" and not the "IRS Tax Account Transcript."

### Non-tax filers who did not file and are not required to file a Federal Tax Return for 2024

Must provide:

- IRS W-2(s) for any employer(s) showing income earned for 2024 with a signed statement stating filing was not required and listing all income sources for 2024
- If no income was earned, a signed statement stating no income was earned for 2024 and income tax filing was not required.
