About

This form is required for verification of information filled out on FAFSA identified by Department of Education that may not match records.

Review the identification requirements, complete the form in-person or in the presence of a notary, and submit form and any required identification to the Grayson College Financial Aid office.

Each person signing this worksheet certifies that all of the information reported is complete and accurate. If you purposely give false or misleading information on this worksheet you may be fined, sentenced to jail or both. I/We also acknowledge that I/we have read and agree to comply with all verification policies as stated by the College. Failure to submit information by posted deadlines may result in the application being filed as inactive with no further consideration and no federal aid for the academic year. Student and parent must sign.

Proof of Identity

In Person

The student must appear in person at Grayson College to verify his or her identity by presenting an unexpired valid government-issued photo identification (ID), such as, but not limited to, a driver's license, other state-issued ID, or passport. The institution will maintain a copy of the student's photo ID that is annotated with the date it was received andthe name of the official at the institution authorized to collect the student's ID.

Not In Person

If the student is unable to appear in person at Grayson College to verify their identity, the student **must provide to the institution a copy of the unexpired valid governmentissued photo identification** (**ID**) that is acknowledged in the notary statement below, or that is presented to a notary, such as, but not limited to, a driver's license, other state-issued ID,or passport.
