## About

This form is required for verification of information filled out on FAFSA identified by Department of Education that may not match records.

## Family Size Information

List the people in your parent(s)' household. This includes:

- Yourself and your parent(s) (including a stepparent) even if you don't live with your parent.
- Your parent(s) other children if your parent(s) will provide more than half of their support from July 1, 2026 through June 30, 2027, or if the other children would be required to provide parental information if they were completing a FAFSA for 2026–2027.
- Other people if they now live with your parent(s) and your parent(s) provide more than half of their support and will continue to provide more than half of their support through June 30, 2027. Not including state funds.
- **Do not** include foster children,

## Income Verification

### Filers

- A signed and dated copy of your and your parent(s) 2024 Federal Tax Return.
- Or, a copy of your and your parent(s) 2024 IRS Tax Return Transcript. You can request a copy of your and your parent(s) 2024 Tax Return Transcript online at [www.irs.gov](http://www.irs.gov) or by calling 1-800-908-9946. Make sure to request the "IRS Tax Return Transcript" and not the "IRS Tax Account Transcript."

### Non-tax filers who did not file and are not required to file a Federal Tax Return for 2024

Must provide:

- IRS W-2(s) for any employer(s) showing income earned for 2024 with a signed statement stating filing was not required and listing all income sources for 2024
- If no income was earned, a signed statement stating no income was earned for 2024 and income tax filing was not required.
