\$360,000

Types of Gifts



These gifts range from \$250 to \$2000 and are awarded in their entirety.



When an individual, business, organization or foundation makes a large contribution (beginning at \$5,000), the principal balance of the fund is invested. The annual earnings from the investment enable the College to award various levels of funding to students and professors. Endowments can be funded with a one-time payment of cash or stock securities, over a multiyear period, and even through gifts from multiple donors.



Gifts that create a lasting legacy are created through the inclusion of the College in a will or as the beneficiary of a life insurance policy.

How Your Gift Can Help

Additional resources are needed to provide the "best in nation" educational services and to foster the learning environment our community needs.

A few priority projects for you to consider are:

Endowed Faculty Chairs

This important funding allows faculty to participate in professional development training above and beyond the usual experiences, and to gather resources and tools to enhance their program.

Innovative Teaching/Learning Fund

This new project will provide resources for new and creative teaching practices and/or learning concepts. This fund enables a Grayson College colleague to be creative in his or her respective field in implementing innovative teaching strategies that support student success.

Make a contribution

1:1 match from employer programs

Frequently Asked Questions

Who will benefit from your gift to the Grayson College Annual Campaign?

Every student who attends Grayson College goes on to make a positive impact on the region, which results in a better community for everyone. The better Grayson does, the more enriched lives we will all have. It's a Win-Win situation!

What are this year's Annual Campaign goals?

- To raise \$360,000 in overall annual giving
- To strengthen our volunteer and donor bases
- To retain students through scholarship support

And you can help achieve these goals!

How do most donors choose to contribute to the Grayson College Foundation?

Grayson College donors often choose to contribute with cash or checks or credit cards, and through Planned Giving. Many also choose to make a gift in the form of stock certificates, "in-kind" gifts such as real estate or several planned giving options. Plus, donors often make annual payments to fulfill a pledge of an endowment.

Are all gifts to the Grayson College Foundation tax deductible?

Since the Grayson College Foundation is a 501(c) 3 corporation, gifts are tax-deductible to the extent allowed by law. Donors should always consult with their tax professional regarding the charitable nature of a contribution

How does employer matching work with my gift?

Participation in the matching gift program can double or even triple the value of your personal gift. Contact your human resource office and inquire about the company's matching gift program. Then complete and send their form(s) in with your gift to Grayson College Foundation.

May I establish a "named" fund?

For as little as \$250, a donor can name an annually-funded scholarship. In order to set up a permanently-endowed named scholarship fund (so that the investment earning generate annual awards year after year), make a contribution at the level in which you wish to perpetuate your contribution.

The Giving Levels chart outlines the established levels and the annual award each endowment level generates.

Can I add to my endowed fund once it is established?

Annual contributions from yourself and/or from others may be designated to the endowment. When the principal cash balance of the fund reaches the next higher level of endowment, we continue to award at the higher level until the fund reaches the next higher level, and so on.

How are scholarships awarded through the GC Foundation?


Students complete the Grayson College General Scholarship Application, which is the application used for a majority of the scholarships available. The applications are submitted to the Grayson College Office of Financial Aid. Those submitting an application and necessary documentation by the Mar. 15 priority deadline are given the highest consideration. Scholarship applicants must also complete the FAFSA process so that each student receives the most assistance available to him or her. Scholarships are awarded as long as funds are available, so even those who apply later are eligible to earn an award.

Do students ever receive cash from their scholarship award?

Only in the form of a reimbursement for personal, out-of-pocket qualified expenses, for which they must produce an original receipt and/or proof of grant or loan funds having been used for such expenditures.

Who selects recipients of Grayson College Foundation awards?

The Foundation forms a Scholarship Committee comprised of five to seven faculty, staff and/or Foundation Board members who meet following the Mar. 15 priority deadline to review applications.



Growth of the Grayson College Foundation

When the Foundation first began awarding scholarships in 1995-96, we funded four students with a total of \$406. The first annual campaign drive was initiated in 1997-98 and the growth has been steadily upward over the next several years. The Annual Campaign started as a scholarship donation drive, and has grown to include funding for other campus programs and needs.
