### Our Program

The Associate Degree Nursing program is a traditional 2-year program, not including the prerequisite and corequisite courses. This is a full-time, in-person program with clinical requirements and some online components. Graduating ADN students will be eligible to sit for the NCLEX-RN exam.

A competitive admissions process is required in addition to applying to the College. Applications are accepted twice a year, and up to 60 students are accepted each admissions period.

- Overall average of 74.5% or higher

## **GENERAL PROGRAM INFORMATION**

The Grayson College Associate Degree Nursing program accepts approximately 60\* students each fall and spring semester. The Grayson College Nursing Department reserves the right to make changes in program enrollment capacity. *\*Subject to change at the discretion of the Grayson College Nursing Department.*

The Grayson College Associate Degree Nursing program is a 2-year program. Nursing courses (RNSG) are separated into four semesters, 16 weeks each, during the Fall and Spring semesters only. Students will not take nursing courses or attend clinical during the summer, unless otherwise indicated by the Grayson College Nursing Department. Students can choose to take other academic courses towards a future Bachelor Degree of Nursing (BSN) during the summer courses if they would like to.

Accepted students should plan to be in class or clinical approximately four days a week at the start of the nursing program. There are approximately 5 hours of lecture content and 1-3 hours of lab class per day with 12-15 hours of clinical per week. These vary from semester to semester, but students will most likely be in class or clinical four days a week throughout the four semesters.

Services are available to assist students with various needs based on race, creed, gender, national origin, or disability. Professionally trained counselors are available to all students and are prepared to assist students in achieving success. A wide variety of counseling and support services are available. For example, a Foreign and ESOL Student Advisor is available to assist international students with a wide variety of needs.

### **Clinical**

If a student has a medical condition which may compromise their ability to care for patients, a medical release from their physician may be required. Based on the environment, students may be exposed to possible infectious diseases.

Clinical sites include locations in: Sherman, TX / Denison, TX / Durant, OK

Students must be able to attend each clinical site on a rotation basis every semester. Reliable transportation is required.

### **Technology Requirements**

Students should have access to internet off-campus in order to complete online coursework and requirements. A laptop or tablet with a camera or webcam and speakerphone will also be required.

Students enrolled in the ADN Program are required to access a learning management system (LMS) used for online, blended, and face-to-face classes at Grayson College. A computer with an internet connection is needed. Computers for student use are available in the Health Science Computer Lab, the Grayson College Library, and other campus computer laboratories. Students will be oriented to the use of LMS and other Health Science technologies at the beginning of each nursing course.

# ADMISSIONS & APPLICATION PROCESS

## 1. APPLY TO GRAYSON COLLEGE

- a. Apply online at <https://www.grayson.com>
- b. Select Nursing University Transfer as your major (not Associate Degree Nursing)
- c. Contact Admissions Office at 903-415-2596 or at [admissions@grayson.edu](mailto:admissions@grayson.edu) for assistance
- d. Applicants are required to be fully or conditionally admitted to be considered for the nursing program.

## 2. ATTEND INFORMATION SESSION or REVIEW SESSION PowerPoint.

## 3. SUBMIT NURSING PROGRAM APPLICATION

- a. **Required Documents** (*only submit the following documents when applying to the nursing program. All other required documents can be submitted at orientation*):

- i. **Applicant Checklist**

- ii. **Application** (important: must be typed)

- iii. **Verification statement**

- iv. **HESI Exam Scores** (Including eligible scores and the 5 required sections, required by application deadline. The date of the HESI must be within 5 years) See page 7 for more information.

- v. **Healthcare Employment Verification document (for PCT and CNA's only)**

- vi. **Transcripts** (official or unofficial of ALL colleges attended)

4. Applications must be submitted to [nursing@grayson.edu](mailto:nursing@grayson.edu) If a picture is taken of your document it must be clear and legible. Paper copies of documents will not be accepted in person or by mail. Applicants are responsible for ensuring updated documents are received by our office by the application deadline.
5. The Nursing Department retains the right to deny applications or documents it deems incomplete, ineligible, or illegible at the department's discretion. *The applicant is responsible for ensuring their application is complete, eligible, submitted, and received by our office by the posted deadlines.* It is recommended that applicants check their emails frequently throughout this process.

## Selection and Acceptance Procedure

1. All applications are reviewed by the ADN Admissions Committee after the application deadline. **Applicants with completed files (including prerequisite courses) will be considered first.**
2. The number of students admitted to the program varies dependent on clinical space, classroom availability and RN faculty availability. Admission selection is based on a points system and the scholastic readiness of the applicant which is derived from all documents submitted.
3. A decision email will be sent to each applicant via their Vikings email whether it be for acceptance, waitlist or non-accepted. An acceptance list and waitlist will be used until courses begin. Applicants on the waitlist will be notified by phone and email if offered a seat in the class. Number of applicants on the waitlist and their position on the waitlist will not be disclosed.

## Coursework Evaluation

It is the applicant's responsibility to ensure applicable courses are eligible to transfer and meet equivalency before they submit a nursing application. To ensure the transferability of previous coursework completed at colleges and universities other than Grayson College, potential applicants to nursing programs are encouraged to have their coursework evaluated by the Health Science Department at least one semester prior to a program application filing deadline if possible. This procedure is especially important for students with coursework from colleges and universities outside the state of Texas. Applicants must be fully admitted GC students for final/official transcript evaluations.

# ACADEMIC ELIGIBILITY CRITERIA

## Courses

### Pre-Requisites:

Courses must be completed with a 'C' or higher and the most recent earned grade will be counted. Required to be completed by the application deadline date.

Pre-requisites in progress may be considered if space allows.

### Co-Requisites:

Courses must be completed with a 'C' or higher and the most recent grade will be counted. Required to be completed by the end of the program in order to graduate.

**Courses not completed by the application deadline will not count towards point calculation.**

### Multiple Attempts at Sciences

Points are deducted per each attempt at a science course. Withdrawals and failing grades count as attempts. The most recent earned grade will be reviewed, final grades must be a 'C' or higher to be acceptable.

There is **no expiration** for science courses or attempts, see HESI information for science courses over 5 years old.

### Minimum GPA

A minimum 2.5 GPA calculated either for pre-requisites or as cumulative is required by the application deadline in order to be eligible for that admissions period.

### Transcripts

1. Prior to applying to a health occupations program, potential applicants must have submitted official transcripts from each higher educational institution attended to the Registrar/Admissions Office after applying to be a Grayson College student and be fully or conditionally admitted to Grayson College for the health science application to be considered.
2. The transcripts must be updated with the print date current within two years of the applicant's anticipated admission to the nursing program.
3. If fully admitted into Grayson College, students can print off official transcripts from their MyViking Document Tracking tab. Grayson College transcripts can be printed off from your My Transcripts tab.

### Transfer Process

If you are requesting to transfer from a different nursing program, you must include with your application: transcripts stating final grades/GPA for current nursing courses, syllabi for each nursing course from time the course was completed, and a letter of Good Standing from your current nursing program Director or Dean. Course evaluation can take several weeks. **Students who have been unsuccessful in other nursing programs are not eligible for transfer.**

### Employment Point

Applicants currently working as a CNA or PCT can submit an employment verification with their application for an extra point.

### HESI Admissions Assessment Test

*This may be changing after Fall 2024 admission*

1. Students can test at any testing center that offers the HESI admissions test (all required sections must be submitted).
2. Required Sections: 1) Reading Comprehension, 2) Grammar, 3) Vocabulary & Knowledge, 4) Anatomy & Physiology, and 5) Math
3. Eligible HESI Test scores must be completed and submitted by the application deadline (current within 5 years)
4. Grayson College requires that students take no more than two HESI admissions tests during a 12-month period
5. Second and *optional* attempt at the HESI Admissions test must be submitted no later than the application deadline

**Applicants must score an overall 74.5% on the HESI Test. If any science courses are over 5 years old, applicant must also score a 75% or higher on the Anatomy and Physiology section of the HESI Test**

## HESI A2 EXAM OVERVIEW

The HESI stands for Health Education Systems, Inc., with A2 standing for Admission Assessment. The HESI A2© (also known as the Evolve Reach Admissions Assessment) is a common health science school entrance exam.

---

### What subjects are on the HESI exam?

The HESI A2© consists of 8 separate test areas. For the Grayson College Nursing Programs, you are required to take only 5 test areas:

1. **Reading Comprehension:** 47 questions, 60 minutes - multiple choice
  2. **Grammar:** 50 questions, 50 minutes - multiple choice
  3. **Vocabulary:** 50 questions, 50 minutes - multiple choice
  4. **Mathematics:** 50 questions, 50 minutes - multiple choice & fill-in-the-blank
  5. **Anatomy & Physiology:** 25 questions, 25 minutes - multiple choice

### How much does the exam cost?

The cost to sit for the exam is \$55.00 at the [Grayson College Testing Center](#), and varies by location. It is best to take the entire exam (all 5 sections) in one sitting, although you can choose to take each section separately. However, the cost is the same no matter the number of sections you choose to test for.

---

### Where do I take the exam?

You are required to register and test for the exam prior to applying to the GC Nursing Programs. You can take the exam at any testing center. You will take the exam on a computer and it will be proctored (someone will be there to watch you take it). You will receive a copy of your scores upon completing the exam, which you will need to submit to the Nursing Program of your choice along with your program application.

### What is a passing score?

The GC LVN Program require a 74.5% or higher in each section, and overall average of the 5 sections to apply to the program. You receive points towards your application based on your average test score.

---

### What happens if I don't pass my exam?

The GC Nursing Programs only allow up to two attempts at the entire exam in a 12-month period. After two attempts at the entire exam in a 12-month period, you will have to wait until the 12-month period is over to sit for the exam again.

---

### Are you allowed a calculator on the exam?

Yes, a calculator is provided for you but you cannot bring your own.

# REQUIRED IMMUNIZATIONS

All applicants accepted into the program will be required to have the listed immunizations. **Do not submit immunizations or health records with your application.** However, it is HIGHLY recommended that applicants begin the process of obtaining these records and getting any missing vaccinations. Please note that some of these immunizations take up to six months to complete. Immunizations must be started in time to complete the series before the start of the program. *During orientation, the accepted applicants will receive instruction of how to subscribe and upload documents into an immunization and health records tracking program.*

1. **TETANUS/DIPHTHERIA/PERTUSSIS (Tdap):** (Immunization) One dose of Tetanus/diphtheria/pertussis (Tdap) immunization within the last 10 years (DTAP or TD not accepted).
2. **MEASLES, MUMPS, RUBELLA (MMR):** (Immunizations or blood test) 2 doses.
3. **VARICELLA (Chickenpox):** (Immunization or blood test) 2 doses.
4. **HEPATITIS B (3 dose series) or HepB (2 dose series):** (Immunization or blood test) Takes 1-4 months to complete.
5. **MENINGOCOCCAL VACCINE:** All on-campus college students who are ***under the age of 22 must*** have the meningococcal vaccination within the previous 5 years and at least 10 days prior to the first day of class.
6. **INFLUENZA VACCINE:** Annual influenza vaccination with the most up-to-date strains predicted on the basis of viral surveillance data is required.
7. **COVID VACCINE:** Grayson College does not require the COVID Vaccine. However, clinical agencies do require COVID Vaccination. Medical and religious waivers are considered. Requirements are subject to change at any time.

## Vaccines

Applicants must be able to complete all required immunizations and health documents by orientation, if accepted to the program.

## Drug Test

Students must pass a urine drug screen and an additional criminal background check at the beginning of the program and prior to the start of clinicals.

## Health Documents

**CPR:** Obtain American Red Cross BLS Healthcare Provider level CPR certification. All CPR classes must include a skills performance check-off in the course (current within 2 years). Our Center for Workforce Learning department offers CPR courses throughout the year, please email them at [cwl@grayson.edu](mailto:cwl@grayson.edu) for their availability.

**TB exam:** Obtain proof of a negative TB (tuberculosis) test. Bloodwork or skin test must be current within 1 year, or negative chest x-ray that is current within 5 yrs.

**Physical Exam:** Required form provided with acceptance/waitlisted email (current within 1 year).

# NON-ACADEMIC ELIGIBILITY CRITERIA

Clinical participation is an integral component to completion of required objectives of the nursing program. In order to participate in this clinical component, students must be able to meet the following requirements.

## Physical/Mental Capabilities

1. Visual acuity with/without corrective lenses to identify cyanosis, absence of respiratory movement in patients, and to read small print on medication containers, physicians' orders, monitors, and equipment calibrations.
2. Hearing ability with/without auditory aids to understand the normal speaking voice without viewing the speaker's face and to hear monitor alarms, emergency signals, call bells from patients, and stethoscope sounds originating from a patient's blood vessels, heart, lung, and abdomen.
3. Physical ability to stand for prolonged periods of time, perform cardiopulmonary resuscitation, lift at the amount required by the clinical agencies, and move from room to room or maneuver in limited spaces.
4. Ability to communicate effectively in verbal and written form. Ability to speak clearly and succinctly when explaining treatment procedures, describing patient conditions, and implementing health teaching. Ability to write legibly and correctly in patient's chart for legal documentation.
5. Manual dexterity to use sterile techniques, insert catheters, and prepare and administer medications by various routes such as Intravenous, orally, and Intramuscular.
6. Ability to function safely under stressful conditions, adapting to ever-changing clinical situations involving patient care.

## Clinical Participation Eligibility (Criminal Background Check policy)

Based on clinical agency requirements, and in accordance with the Grayson College Health Science Criminal Background Check Policy, any student with the following criminal history may be required to obtain a Declaratory Order from the Board of Nursing prior to admission to the program, and could possibly be prevented from clinical placement at a healthcare agency.

**\*\*Any student with a criminal history listed above will be required to obtain a Declaratory Order from the Board of Nursing prior to admission to the program. The student must inform the Program Director of the outcome of the petition for Declaratory Order by providing a copy of the clearance letter received from the Board of Nursing and the Declaratory Order with or without conditions received from the Board, or the letter of denial received from the Board. Failure to provide documentation prior to admission to the program can disqualify an applicant\*\***

The following convictions at any time in the past will constitute an **absolute bar to participation in clinical rotations**:

Criminal homicide; kidnapping and unlawful restraint; indecency with a child; sexual assault; aggravated assault; injury to a child; aiding suicide; agreement to abduct from custody; sale or purchase of a child; arson; robbery; aggravated robbery; conviction under the laws of another state, federal law, or the uniform Code of Military Justice for an offense containing elements that are substantially similar to the elements of an offense listed previously; felony conviction for theft which occurred within the previous five years and any other offense that a facility may impose.

## **TEXAS BOARD OF NURSING CLEARANCE DOCUMENTATION**

**NCLEXRN Clearance Documentation:** Provide proof of eligibility to take the NCLEX-RN Examination with one of the following documents from the Texas Board of Nursing:

1. Blue Card stating eligibility to sit for the NCLEXRN Examination
2. Operations Outcome letter
3. Enforcement Outcome letter
4. Eligibility Order
  - a. Applicants selected as accepted or waitlisted by the Grayson Nursing Program, will be submitted to the Texas BON to initiate the background check process.
  - b. The Texas Board of Nursing will contact the applicant by email if the applicant is chosen to undergo a fingerprinting process. The applicant is responsible for fees associated with the fingerprinting process. The Texas Board of Nursing will provide mailed NCLEX clearance documents directly to the applicant several weeks after processing the applicant's criminal background information.
  - c. The last day to provide a copy of the proof of eligibility (clearance documents) is by Nursing Bootcamp day. If unable to provide by that date, the student will not be allowed to start the nursing program.
  - d. The Grayson College Nursing Department is not responsible for any delays regarding the background check process.
  - e. *Applicants who fail to provide proof of eligibility will not be admitted into the program. If restrictions are placed on the applicant due to the criminal background check, admission into the program may be denied or revoked at the discretion of the department.*

The Texas Board of Nursing (BON) requires all applicants for Licensure in Texas to apply and pay for the Department of Public Safety/Federal Bureau of Investigation background check and fingerprint scanning. Grayson College Nursing program requires that this be completed PRIOR to final admission. **Clearance documentation from the BON must be provided by the scheduled date. If unable to provide by that date, the applicant will forfeit their acceptance for that admission period.**

**\*\*\*IF YOU ANSWER “YES” TO ANY OF THE QUESTIONS BELOW OR THE DPS/FBI BACKGROUND CHECK AND FINGERPRINT SCAN DETERMINE THE NEED, YOU MAY BE REQUIRED BY THE BOARD OF NURSING TO BEGIN THE DECLARATORY ORDER PROCESS.**

Results of the DPS/FBI Background check and fingerprint scan may prohibit final admission to the program until the Declaratory Order is received by the student from the Texas Board of Nursing. The student must inform the Program Director of the outcome of petition for Declaratory Order by providing a copy of the clearance letter received from the BON and the Declaratory Order with or without conditions received from the Board, or the letter of denial received by the Board.

If you can answer “Yes” to any of the following you may be required to file a Petition for Declaratory Order to determine eligibility to sit for the NCLEX®-RN exam following graduation.
