Subject: Quarterly Investment Report – Q1

The attached investment report details the investments held by Grayson College as of November 30, 2024. This is for the first quarter of the fiscal year and covers the time period of September 1, 2024 to November 30, 2024. The college followed its investment policy and applicable state law as of that date.

Investments owned by Grayson College are either federally insured, maintains pledged securities, invested in high grade commercial paper or government securities including treasury notes and bills.

The total market value of the college's investments that are invested in either a Certificate of Deposit (CD), Money Market (MM), checking account or state investment pools as of November 30, 2024 is \$158,644,596.

The weighted average yield of the portfolio was 4.76% as of November 30, 2024.

Beginning in January 2025, the bond proceeds have been laddered out with Texas Daily Select – a local government investment pool to correspond with projected expenses for an overall rate of 4.37%. GC is exploring additional laddering for operational funds.

This report meets the requirements of the Public Funds Investment Act and the Grayson College Investment Policy.
